

100th Year Anniversary



Square Knot Award

Are you a Marine Corps League (MCL) member and a registered leader with the #BoyScouts of America (#BSA)?



MCL members are eligible to be presented the Community Organization Award (#SquareKnot Award) for registered leaders to wear on their #Scouting uniform. The MCL member will need to fulfill the requirements set forth and submit the appropriate paperwork to be considered for this award. This is a BSA award created for partner organizations to give as a recognition/award for their members to wear on their BSA uniform. A reminder that the BSA has a policy that prohibits the wearing of non-BSA awards on its uniforms.

This paperwork has been added to the MCL Library web site in the Scout program area.

The BSA and the MCL have agreed to initiate a plan of mutual support to foster the ideals of #Americanism and patriotic #volunteerism among America's youth. Councils are encouraged to expand their involvement of support for causes specific to the MCL and our nation's veterans at large. MCL detachments are encourage to expand their involvement in support of BSA programs toward our mutual goals for a better and more patriotic America.

The MCL strongly believes that our youth are our future and that it is our responsibility to prepare them for that future. The Scout Oath and Law that the BSA instills in youth is a strong foundation for future success.

It is that time of the year when Detachments start the election process for the coming year. National and Department

Bylaws and Administrative Procedures mandate that each Detachment must hold their annual elections between October 1 and May 15. Both National and Department have reporting requirements that must be followed. I have listed information below that will help your Detachment with the process. Installing Officer — The Officers below are the only officers that can install your Detachment: National Commandant, Elected National Officer, Past National Commandant, Department Commandant, Elected Department Officer, Past Department Commandant, Detachment Commandant, Past Detachment Commandant Note: If you are requesting the Department Commandant or an Elected Department Officer. Required reports: Report of Officer Installation — This form is available by going to the National Headquarters website, www.mclnational.org. Type in "forms" in the search box and then "click" on Officer Installation. This will bring up the Report of Officer Installation form. Type in all the appropriate information required. Then print the completed form for your files. Obtain the signature of the Installing Officer and the individual completing the form and mail or email the completed form to the Department Adjutant within 10 days of the installation.

Paymasters..... If you have new members joining the League between March 1 and June 30, remember that their National dues are reduced from \$25 to \$15. (Use the appropriate code as indicated at the bottom left of the Transmittal form. The catch is that their regular annual dues payment is due again on August 31.

You should regularly compare your roster to a real headcount check with your members. A recent change in the member database will now drop members from your roster if they are more than one year overdue. If they are more than one year past due, and you send in enough for a single annual payment, they will still show up as delinquent because National will apply the payment received to the most delinquent year. Unfortunately, at this time you can't easily see how far behind a member is with your access from the Detachment level. Hopefully, that will soon be fixed, but in the meantime, if you have a member not on your roster, you can contact me and I can get more details on their payment history.

If you have a member who has dropped off your roster due to non-payment, you'll need to submit a new application along with the transmittal to get them restored.

Any Detachment officer can request a current roster by emailing me. I can pull them on demand and send a pdf copy to your email address.

Change of address or phone number... You should no longer use the Transmittal form to submit a change of address or phone number for your members. Detachment Commandants and Paymasters have access to the Database Portal in the Member Library. If you're not familiar with the portal, there is a training package in the Library. You access the Library by going to www.mclnational.org; then click on the *Visit Now button* next to the Marine Corps League Library. Click on *Member Library* to get to the training; click on *Database Portal* after the training in order to actually perform the updates. A password is required to access the Member Library. If you don't know it, contact me.

One additional item on Transmittals... you only need to submit one single copy to me – along with a single check for the combined payment for the National and Department dues. Department dues are currently \$3 for each new member – and renewal. If a member is paying to become a Life Member, the annual dues must be current. If not current, the member must pay the annual dues amount before (or along with) the **Life Member** amount. If the member is already current, there is no separate amount due to the Department to become a Life Member. If delinquent, then pay the regular amount (plus the Department fee), then pay the Life Member amount (without the Department fee). A new member can join and immediately become a Life Member using the same Transmittal, but again, they must pay the regular annual fee in addition to the Life Member dues.

VSO Stipend for Honor Guard Funeral Services

In June 2022, South Carolina Governor Henry McMaster signed legislation (Act No. 225) entitled Veterans Service Organization Burial Honor Guard Support Fund, which provides a stipend to congressionally chartered veterans service organizations that provided an honor guard burial detail at the funeral of a qualifying South Carolina veteran.

The minimum stipend is fifty dollars (\$50) per funeral detail, but may not exceed the per funeral cap established by the Secretary of the Department of Veterans' Affairs. (The current cap is \$100 per funeral). To claim the stipend, you must download and submit a Request for Reimbursement to the Secretary of Veterans Affairs no later than the 15th of the month following the date the funeral was conducted.

You can find the form on the SC Department of Veterans Affairs website, www.scdva.sc.gov. In the search box, type the word "documents" then look for "STANDARD OPERATING PROCEDURE. Veteran Service Organization (VSO) Burial Honor Guard Support fund." Prior to submitting the first request for reimbursement, you'll need to obtain a State Vendor Number for the Honor Guard unit.

A link to the instructions for this process is included in the form downloaded previously. As you go through that process, you may find it worthwhile to also sign up for direct deposit into the Honor Guard's bank account. Once you've registered as a vendor and prepared your reimbursement request form, you should submit the form electronically to VSOHonors@scdva.sc.gov. (This is not the address that is indicated on the form, but it is the one that will ensure that the form reaches someone who will take action on it).

Statement by Secretary of Defense Lloyd J. Austin III on International Women's Day March 8, 2023

Today, on International Women's Day, the Department of Defense recognizes the tremendous, enduring contributions that women Soldiers, Sailors, Marines, Airmen, Guardians, and civilian employees have made in service to our country.

From America's first days, women have made profound sacrifices for our republic. They have made innovative contributions to our national security, blazed trails for future generations, and inspired us with their dedication, skill, and patriotism. Since the Revolutionary War, more than three million women have stepped up to serve their country in uniform, even before the military fully recognized their service.

This year, we mark the 75th anniversary of the Women's Armed Services Integration Act, which paved the way for women to officially serve in all U.S. military branches, and the 10th anniversary of opening all combat roles to women. The logic behind these decisions was clear and compelling: Our military needs the best warfighters in every domain. That remains true today.

Though the Department has made significant progress to break down stubborn barriers for women in the U.S. military, we know that we still have more to do to promote inclusion and well-being and to give all our teammates the opportunity to rise to their full potential. VA will propose adding rare cancers to the presumed serviceconnected list as related to military environmental exposure

WASHINGTON — The Department of Veterans Affairs intends to propose adding certain rare respiratory cancers to the list of presumed service-connected disabilities in relation to military environmental exposure to particulate matter.

VA determined through a focused review of scientific and medical evidence there is biologic plausibility between airborne hazards, specifically particulate matter, and carcinogenesis of the respiratory tract, and that the unique circumstances of these rare cancers warrant a presumption of service connection.

Based on these findings, VA's Secretary is proposing a rule that will add presumptive service connection for several rare respiratory cancers for certain Veterans. The cancers under consideration include:

- Squamous cell carcinoma of the larynx.
- Squamous cell carcinoma of the trachea.
- Adenocarcinoma of the trachea.
- Salivary gland-type tumors of the trachea.
- Adenosquamous carcinoma of the lung.
- Large cell carcinoma of the lung.
- Salivary gland-type tumors of the lung.
- Sarcomatoid carcinoma of the lung.
- Typical and atypical carcinoid of the lung.

"This is the right decision. The rarity and severity of these illnesses, and the reality that these conditions present a situation where it may not be possible to develop additional evidence prompted us to take this critical action," said VA Secretary Denis McDonough. "We'll continue to hold ourselves accountable to Veterans to provide more care, more benefits and more services to more Veterans than ever before."

VA intends to focus its rule on the rare respiratory cancers above in Veterans who served any amount of time in the Southwest Asia theater of operations and other locations. VA will invite and consider public comments as part of this process.

Once rulemaking is complete, VA will conduct outreach to impacted veterans and survivors to inform them about potential eligibility

Those currently enrolled in VA's current policy for service-connected Veterans, <u>Service-Disabled Veterans Life Insurance (S-DVI)</u>, may keep their coverage or switch to VALife.


Although creativity has no rules, there are a few submission guidelines:

- The design will be used for a 1" x 1.5" lapel pin. Simple designs look best scaled down to lapel pins. If you'd like to submit a modified design for the lapel pin based on the original poster design, you may do so.
- Submissions are not restricted to "human-centric" images, such as a joint color guard. Images of American icons, monuments or scenery can qualify.
- Submissions must be representative of all Veterans who served. The Committee may select a particular submission but ask the artist to modify the original design. Additional changes may be required prior to printing.
- Each design must include the words "Veterans Day," "November 11, 2023," and "Honoring all who served."
- All submissions must include sufficient information to demonstrate that the image is the artist's work and is not copyrighted material (i.e., photos and concepts).
