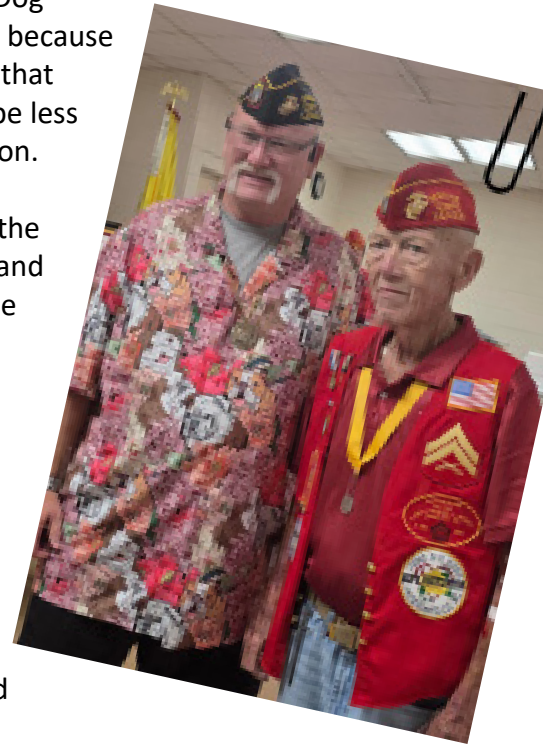
Woof-Woof Dogs of the Order!

Membership Awards

Division Level:

KENNEL CHILDREN'S HOSPITAL DONATION:

We are off to a fantastic start already! As of 4 September 2025, we have 20,513 Big Bones in our account. The fiscal year ends on 30 June.

BUDGET:

The Kennel Budget for fiscal year 2025-2026 was published in the last issue of the Woof-O-Gram. It was approved by the membership on 13 August 2025, at the Supreme Growl.

OPERATION CHOW HOUND:

As of 4 September 2025, we have 1,647 Big Bones in our account. The fiscal year ends on 30 June.

The OCH Program has been a tremendous success and continues to grow. OCH is a voluntary program. You may collect food, supplies, and/or Big Bones to donate to your local no kill shelter. This may be done on every level: Pound, Pack, and Kennel. Go to the Kennel Website for the OCH Reporting Form, Receipt of Donation Form, and Logo. There is no requirement to report your donations to the Kennel. All Pounds and Packs who would like to track their donations and send in the report are encouraged to do so. These reports should be emailed to the Honorable Jr. Vice Chief Devil Dog no later than 1 June, prior to the Supreme Growl. Please compile all donations into one total 12-month report, for the period 1 June – 31 May. The Honorable Quartermaster has “Pound K-9” kits for your pets. The cost is 20 Big Bones. The 2025 OCH Patch is currently available in the Kennel Store for 6 Big Bones. Big Bones made from Pound K-9 Kits and OCH Patches will be included in the annual donation for OCH at the 86th Supreme Growl.

The job of the Jr. Vice Chief Devil Dog can be simplified as FUN & FUNDRAISING. It has been my mission to teach and encourage Dogs to have FUN as I travel around the Kennel. The Online Kennel Raffles are a key component of our overall fundraising. Your support is essential to our success.

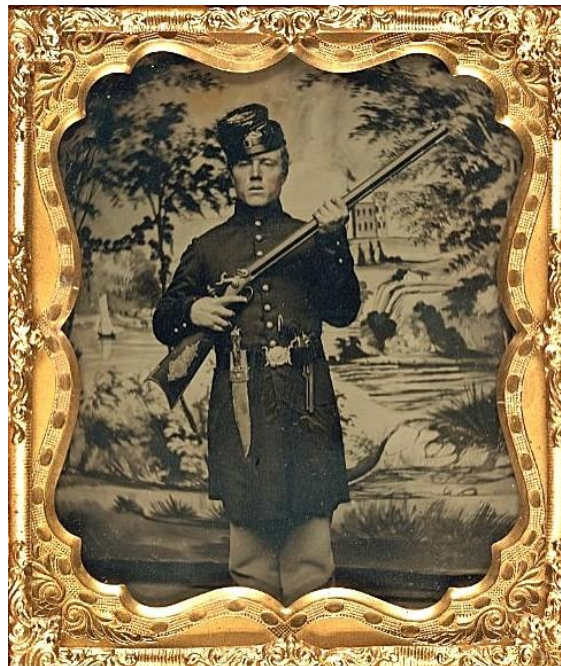

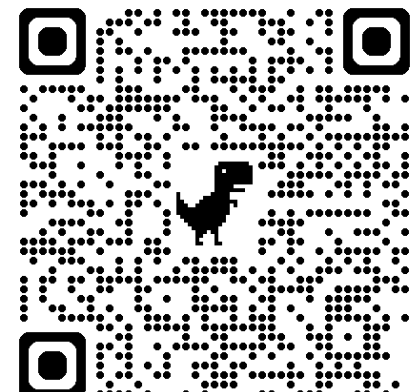
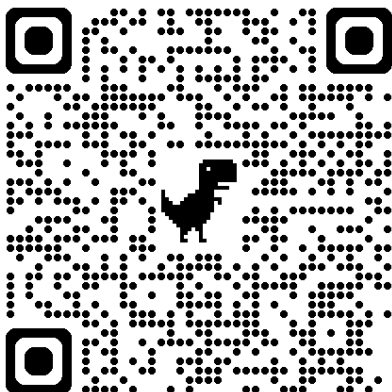

I understand that change can feel like learning new tricks, and not every Dog is eager to jump through that hoop right away. But you will not be alone. The Kennel is committed to offering training, guidance, and support to help every Dog Robber succeed. Remember: we are the caretakers of our Pounds', Packs', and Kennel's records, and by embracing these tools, we ensure that we can continue our duties with excellence and without delay.



So, Dogs, let us face this change together with the same loyalty, determination, and good humor that define us. If you did not go to the National Convention and Supreme Growl, you missed a great time in Grapevine, Texas. There were 91 Initiates and 325 non-Initiates, for a total of 416 Military Order of the Devil Dogs in attendance at the Convention.

The next Convention will be in Indianapolis, Indiana, next August. If you are planning to advance in Indianapolis, now is the time to let your Pound Dog Robber know that you want to advance, so they can begin getting the paperwork in order and sent to the Pack Dog Robber. The Pound Dog Robber can begin submitting the paperwork anytime between now and the beginning of June. All paperwork must be in the Kennel Dog Robber's paws prior to July 1, so get it in as soon as possible.

Woof Woof Dogs!

Yes, it is that time of year too let you know that you should be starting on the road to PDD. It is never too early. This edition will give information on what to do if you have to be seen at a hospital, and the free insurance policy offered to all Marine Corps League Members in good standing.

First, what to do if you are seen in an ED or admitted to hospital:

1. If you are a Veteran and you were seen in any hospital emergency room either as a walk-in or taken by ambulance, you need to call the VA Hotline within 72 hours. You need not to be in the VA System to call.
2. When you call, you will be asked a few simple questions, name, what hospital were you seen or admitted to, SS number, and address.
3. The 72 Hour Hotline is 844-724-7842.

This call can be made by the Veteran, the family, or close friend. The VA will contact the medical facility, to make sure all information is correct. If the VA is satisfied, you will be contacted for possible bill adjustment.



Second, I want to pass information on an insurance program offered thru the Ailife Insurance Co.

Q. What are the payout for the different levels, death/dismemberment?

All members are protected with a \$3,000.00 Accidental Death & Dismemberment benefit. No one has to sign up for it. We will pay a claim if they die in an accident as long as they are a member in good standing. We prefer that members fill out the beneficiary card that comes with the letter, but we will still pay a claim if they do not.

Q: Is this offered in all states?

All current and future members of the Marine Corps League of Maryland are eligible for the no cost benefits. We would be able to provide the benefits nationally if the Marine Corps League partnered with us at the national level.

Q Does the company have an agent in all states?

American Income agents are located throughout North America. They contact members who return a beneficiary card so that they can get them set up with their no cost benefits as well as inform them of policies that are available for purchase.

Q: Is there a central number to call?

Members can call AIL Policy Owner Services at 254-761-6400 for questions about life insurance policies they purchase (not the no cost benefits).

Q: Does the State Commandant get involved?

The no cost benefits are provided through a partnership with the Marine Corps League of your state. The State Commandant must sign off with the insurance. Contact your State Commandant asking him/her to sign off on this free AD&D program.

The no cost benefits available to all members include:

- AD&D benefit
- AIL Plus Medical Discount Plan
- Will Kit
- Child Safe Kit
- MediFacts Kit
- Members can go to <https://mybenefits.ailife.com/> and enter access code SGP2C to connect with an agent for help.

Maryland has had this program for over eight years. When I was Commandant, the benefit was paid to two families.

Greetings Dogs of the Order!

This is a very busy time of the year with elections/installations and ROI submissions, tax filings of 990n's for all fiscal year filers, and any states that require filings of their annual business renewals.

A reminder when you send me your 990n confirmations. I must have the "ACCEPTED" receipt issues by the IRS or I cannot mark you in compliance. It may take months for the IRS to update your filing status in order for me to mark you current.

I am currently working on getting all the Packs and Pounds in compliance with the Kennel Bylaws. There were 44 Packs or Pounds that either were not under the Marine Corps League 0955 grouping, did not have a deductibility code of 1 (authorized to receive donations), not registered as a 501(c)4, or were under a tax reporting period of something other than fiscal year (1 July to 30 June). With the help from the COO of the Marine Corps League, letters were sent to the IRS requesting the corrections be made to the records in order to bring them in compliance. 31 out of the 44 letters were accepted and the changes were made. I sent a list to your Division Vice Chiefs and they should have notified you if your reporting period changed.

We still have 59 Packs/Pounds that are not in a fiscal reporting period (1 July – 30 June). In approximately a month, letters will be sent to the IRS requesting them to change those to be in compliance with the Bylaws. Once this is done and I check for the change to be made, I will send a list to your Division Vice Chiefs to disseminate the information down the chain of command. Just be aware that if you are not filing your 990n's on a fiscal year period, this will be changing in the future.

One last comment, as of the writing of this letter, there are still a lot of 990n's that are either due or past due. If you are still on a calendar year filing, your taxes were due by the 15th of May. If fiscal year you have until the 15th of November. Please get these filed and make sure I get an accepted copy.

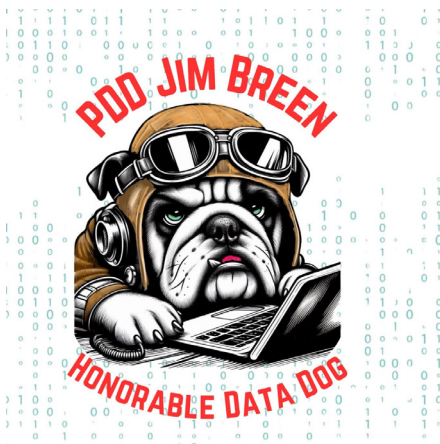
Looking Ahead: Mobile Application Development

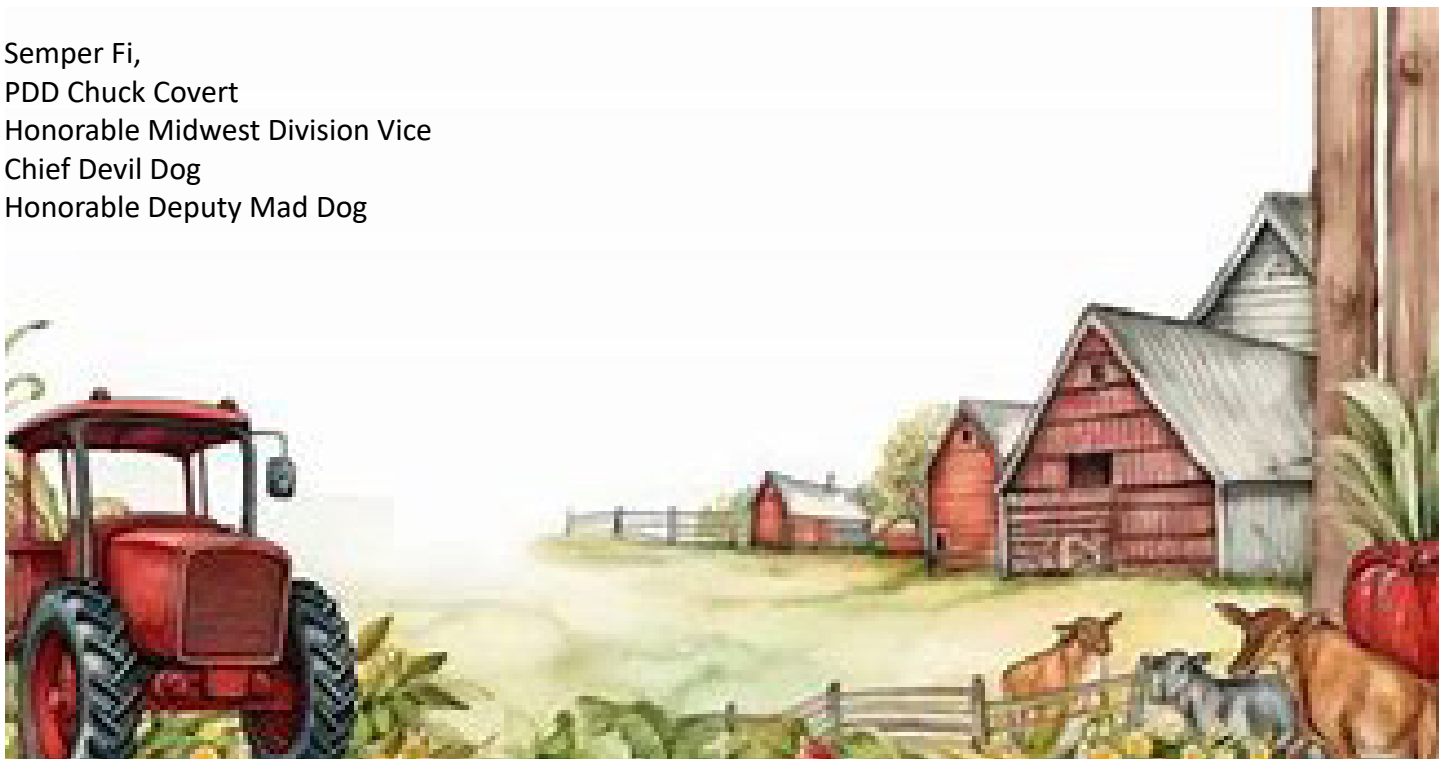

Gather, Give, and Grow - Seasonal Inspiration for Our Membership from the BOT: PDD Stephanie Abbott

Ref: Kennel Bylaws Article II Section 208

I would like to recommend the following proposed Bylaw change for consideration.

Article II Section 208- Eligibility to Hold Office section A sub paragraph 3.

Currently reads:

- A. All members of the Pound shall be eligible for election, or appointment, to any office in the Pound, Subject, however, to the following limitations and restrictions:
 - 1. The Pound Keeper must have the Degree of Devil Dog or Pedigreed Devil Dog, with the Degree of Pedigreed Devil Dog being preferred.
 - 2. It is preferable that the Pound Dog Robber has the Degree of Devil Dog or Pedigreed Devil Dog.
 - 3. To be eligible for an elective or appointive office, a Pup must have been a faithful Pup for at least one calendar year. This restriction may be waived ONLY when the fifth person making application for a Pound Charter is a Pup, who may be a proper Charter Applicant, and the Pup Charter Applicant may hold any Appointive Office other than that of the Pound Dog Robber. A Pup will be eligible to hold any office in the Pound that is elective other than the Pound Keeper and Pound Dog Robber.
 - 4. All officers must be currently paid up in membership dues in the Marine Corps League, Inc., and in the Order.
 - 5. Any officer permitting their membership dues and good standing in the Marine Corps League, Inc., and in the ORDER, to lapse, shall forthwith surrender their office, and the office be declared vacant.
 - 6. Any nominee for any elective office must be present at the time their name is placed in nomination and shall accept the office, except for valid reasons. The DOG ROBBER provided they have stated by written word their acceptance of the office if elected, may be nominated and elected in absentia.

Change to read

Section 208- Eligibility to Hold Office section A sub paragraph 3.

- A. All members of the Pound shall be eligible for election, or appointment, to any office in the Pound, Subject, however, to the following limitations and restrictions:
 - 1. The Pound Keeper must have the degree of Devil Dog or Pedigreed Devil Dog, with the degree of Pedigreed Devil Dog being preferred.
 - 2. It is preferable that the Pound Dog Robber has the degree of Devil Dog or Pedigreed Devil Dog.

3. To be eligible for an elected or appointed office, a Pup **should be** a faithful Pup for at least one (1) calendar year. This restriction may be waived ONLY when the fifth person making application for a Pound Charter is a Pup, who may be a proper Charter applicant, and the Pup Charter applicant may hold any appointed office other than that of the Pound Dog Robber. A Pup will be eligible to hold any office in the Pound that is elected other than the Pound Keeper. **or if there are no other eligible Dogs to accept the nomination to an Elected or Appointed position during regular elections within the Pound, then a PUP who has attended a minimum of two Growls may be nominated and elected or appointed to a position within the Pound except for the position of Pound Keeper or Pound Dog Robber.**
4. All Officers must be currently paid up in membership dues in the MCL, and in the MODD.
5. Any Officer permitting their membership dues and good standing in the MCL and in the MODD, to lapse shall forthwith surrender their office, and the office be declared vacant.
6. Any nominee for any elected office must be present at the time their name is placed in nomination and shall accept the office, except for valid reasons. The Dog Robber, provided they have stated by written word their acceptance of the office if elected, may be nominated and elected in absentia.

Rational:

By changing this too SHOULD be a faithful Pup for 1 calendar year, would allow those Pups who are wanting to step up and accept a position within the Pound, have a chance to do so. If they feel like they are involved and have a purpose in the Pound, they will continue to attend Growls and be a productive Dog in the Order.

Article IX Section 901 Pounds

Currently reads:

- A. The Officer installing the new Officers of a Pound should be a Pedigreed Devil Dog if possible, or shall be a Past Pound Keeper, or an incumbent elected Pound Officer, or past elected Pound Officer, or current/past Pack elected Officer, or current/past Kennel elected Officer.

Immediately following the Installation, the Installing Officer shall make a full report to the Pack Dog Robber, the Honorable Dog Robber and the Vice Chief Devil Dog of the Division. The report shall include the date and place, names, addresses and titles of all Officers installed.

Change to read

Article IX Section 901 Pounds

- A. The Officer installing the new Officers of a Pound should be a Pedigreed Devil Dog if possible, or shall be a Past Pound Keeper, or past elected Pound Officer, or current/past Pack elected Officer, or current/past Kennel elected Officer. Immediately following the Installation, the Installing Officer shall make a full report to the Pack Dog Robber, the Honorable Dog Robber and the Vice Chief Devil Dog of the Division. The report shall include the date and place, names, addresses and titles of all Officers installed.

Rationale

There is not a proper way for an incumbent elected Pound Officer to properly swear themselves in. By removing "or an incumbent elected Pound Officer" ensures that the Pound Officers are properly installed.

Immediately following the Installation, the Installing Officer shall make a full report to the Honorable Dog Robber, via the Vice Chief Devil Dog of the Division, including the date and place, names and addresses and titles of all Officers installed and the current condition of the Pack.

I would like to recommend the following proposed bylaw change for consideration.

Article V Section 505 Passports / Visa Stamps

Currently reads:

- A. All Devil Dogs shall procure a the MODD Passport at a cost regulated by the Kennel, which will distribute them to the Packs and the Pounds. The fine for attending any Kennel, Pack, or Pound Growl will be one dollar (\$1.00) without a Passport in any attending Devil Dogs possession.
- B. The Kennel, Packs, and Pounds will procure a Visa Stamp to stamp all Passports with the date of all Growls attended by said Devil Dog presenting their Passport. Cost of visa stamping shall be one dollar (\$1.00).
- C. All monies collected for Passport or visa stamping shall be forwarded after each Growl to the Honorable Dog Robber, who will hold these monies in a special Passport account.
- D. All monies collected will be used each year at the MCL National Convention, where a check for a sizable portion of that account will be presented first, to a children's hospital in the convention city, or to another suitable local charity as the Executive Board of the MODD, may select. The check shall be accompanied by a letter stipulating that the MODD's contribution is to be used for special equipment purchases only and for no other purpose.
- E. Any Devil Dog Passport that is lost, or misplaced, not stolen, if turned into either the Kennel, Pack, or Pound Dog Robber, shall be stamped four times and returned at a cost of two dollars (\$2.00), as a finder's fee.

Change dollars to Big Bones and add sub paragraph F.

- A. All Devil Dogs shall procure a the MODD Passport at a cost regulated by the Kennel, which will distribute them to the Packs and the Pounds. The fine for attending any Kennel, Pack, or Pound Growl will be one big bone (\$1.00) without a Passport in any attending Devil Dogs possession.
- B. The Kennel, Packs, and Pounds will procure a Visa Stamp to stamp all Passports with the date of all Growls attended by said Devil Dog presenting their Passport. Cost of visa stamping shall be one big bone (\$1.00).

- C. All monies collected for Passport or visa stamping shall be forwarded after each Growl to the Honorable Dog Robber, who will hold these monies in a special Passport account.
- D. All monies collected will be used each year at the MCL National Convention, where a check for a sizable portion of that account will be presented first, to a children's hospital in the convention city, or to another suitable local charity as the Executive Board of the MODD, may select. The check shall be accompanied by a letter stipulating that the MODD's contribution is to be used for special equipment purchases only and for no other purpose.
- E. Any Devil Dog Passport that is lost, or misplaced, not stolen, if turned into either the Kennel, Pack, or Pound Dog Robber, shall be stamped four times and returned at a cost of two big bones (\$2.00), as a finder's fee.
- F. The minimum required items that are to be presented with a Dogs Passport are, their current MCL and MODD membership cards, either the hard copy or an electronic copy. Pounds and Packs may add additional items at their discretion.

Rationale:

We do not use dollars in the MODD, we use Bones. There is not a current list of items that are required to be in the Passport. Dog Robbers always ask to see these items, but they were never officially listed anywhere in our By Laws, Ritual or Handbook that a Dog must have these items in their Passports. This change will list the bare minimum items that are required to be in every Dogs Passport and still give the Pounds and Packs a chance to add their own required items to the passports.

2. The Honorable Chief Devil Dog after assuming office may appoint such other Kennel Officers and Honorable Vice Chief Devil Dogs of Divisions and Aides as he/she may see fit may also be appointed as may be fit and proper and such appointed Officers shall serve only at the convenience and pleasure of the Honorable Chief Devil Dog.

Proposed Language:

2. The Honorable Chief Devil Dog after assuming office may appoint such other Kennel Officers and Honorable Vice Chief Devil Dogs of Divisions and Aides as he/she may see fit may also be appointed as may be fit and proper and such appointed Officers shall serve only at the convenience and pleasure of the Honorable Chief Devil Dog.

3. The Honorable Vice Chief Devil Dog of the Division may be appointed provided that such appointees are not currently holding office as Worthy Pack Leaders.

Rationale: It is important to have a clear chain of command and separation of powers so if an issue arises there is no conflict of interest, leaving the only option from Pack issue to Kennel being official complaints.

Subj: MODIFIED Proposed Changes to Kennel Bylaws, Article IV, Section 410

In accordance with MODD Constitution and Bylaws (Revised 2023), Article IV, Section 403 and Article XIII, Section 1301 the following is submitted for consideration.

Proposed bylaw changes to Section 410: Nomination / Election / Installation / Tenure

Section 410: D Tenure. 4.

CURRENT:

The Honorable Executive Director shall be a permanent, compensated position, subject to the annual approval of the Honorable Chief Devil Dog. The Honorable Executive Director shall be appointed from the ranks of qualified Pedigreed Devil Dogs who are extremely knowledgeable in the administrative affairs and duties of the MODD. The Honorable Executive Director shall be paid an annual honorarium as defined in the Kennel's annual budget. Should the Honorable Executive Director decline the position for another term, he/she must, within thirty (30) days after the Supreme Growl of the Kennel turn over all monies and records to the newly appointed Honorable Executive Director.

PROPOSED:

Section 410: Nomination / Election / Installation / Tenure.

D Tenure. 4.

- a. The office of Kennel Executive Director shall be a permanent compensated position.
- b. The Honorable Executive Director shall be nominated from the ranks of qualified Pedigreed Devil Dogs who are extremely knowledgeable in the administrative affairs and duties of the MODD by the Chief Devil Dog and approved by a simple majority vote of the Kennel Board of Trustees.
- c. The Honorable Executive Director shall be paid an annual honorarium as defined in the Kennel's annual budget.
- d. The Honorable Executive Director may succeed him/herself for as many terms of office as they are reappointed. The Honorable Executive Director may be reappointed by successive Honorable Chiefs Devil Dog.
- e. The Honorable Executive Director may be removed from office, with or without prejudice, by the Honorable Chief Devil Dog.
- f. Should the Kennel Executive Director (KED) decline the position for another term or be removed from office by the Honorable Chief Devil Dog, he/she must, within thirty (30) days after the Supreme Growl or date of removal, turn over all monies, records, passwords, and

- g. [other items necessary for the day-to-day operation of the Kennel](#), to the newly appointed or interim Honorable Kennel Executive Director.

RATIONALE:

There is a conflict between being in a permanent compensated position yet requiring annual appointment. Separating the office from the person (Dog) removes any ambiguity.

It is understood that the Honorable Chief Devil Dog should have the prerogative to select his/her Kennel Executive Director. However, the constant churning of KEDs could undermine the Kennel's operations. Requiring the consent of the Board of Trustees provides incentive to conduct due diligence on the nominee's qualifications.

The duties and responsibilities of an executive director are to manage the day-to-day operations of an organization. The KED works closely with the Board of Trustees, the Kennel Dog Robber, Webmaster, and Quartermaster. The KED also works closely with the Honorable Senior Vice Chief Devil Dog and Webmaster to create and maintain Kennel membership rosters. Additionally, the KED maintains the Kennel's checking and savings accounts. The KED is the single collection point for funds raised by the Operations Dog, Lucky Dog, and others. The KED makes all bank deposits following a Supreme Growl.

Such duties require a high level of training, experience, and education in areas such as book and record keeping, insurance, and overall business acumen. Continuity and "corporate (Kennel) knowledge" are essential to the smooth running of the organization. A constant turnover in KEDs would be detrimental to the stability of the Kennel.

This bylaw change would allow the KED the ability to plan ahead with the Kennel Board of Trustees, Past Chiefs Society, and others, and see those plans to completion without the uncertainty of yearly turnover.

Article I Section 101 B: The Degrees of Membership in the MODD

Currently reads:

1. The degree of Pup to be granted to all qualified candidates at any Growl of the Pound; by limitation hereinafter set forth, may also be granted the degree at the Pack and Kennel level.
2. The degree of Devil Dog to be granted to all qualified candidates at any Growl of the Pack; by limitation hereinafter set forth, may also be granted at the Kennel level.
3. The degree of Pedigreed Devil Dog to be granted to all qualified candidates ONLY at the Supreme Growl of the MODD

Change to add sub paragraph 4 & 5

4. The degree of Chief Devil Dog (CDD), be granted to all those who are properly elected and installed by vote of the Order Only during the Annual Supreme Growl.
5. The degree of Past Chief Devil Dog (PCDD), be granted to any CDD that has completed their duties as Chief Devil Dog of the Order immediately at the election and installation of the new CDD.

Rationale:

The Honorable Chief Devil Dog and the Honorable Past Chief Devil Dogs will never again wear the Gold Collar which is symbolic of the Pedigree Devil Dog; nor will they ever again hold the title of PDD. The Honorable Chief Devil Dog will be referred to, addressed as and identified as "The Honorable Chief Devil Dog" and will wear the appropriate Medallion representing the Honorable Chief Devil Dog.

The Honorable Past Chief Devil Dogs will be referred to, addressed as and identified as "Honorable Past Chief Devil Dog" and will wear the appropriate Medallion representing an Honorable Past Chief Devil Dog.

Existing Wording:

SECTION 201: Definition

B. The Pound shall bear a number as determined by the Honorable Dog Robber, being issued in sequence and in addition shall bear such name as the members of the Pound may choose, except that no Pound shall bear the name of a living person or of a Pound already in use. It is preferable, but not mandatory, that the Pound bear the name of the Detachment of the MCL from which it obtains the majority of its members.

Proposed Wording:

B. The Pound shall bear a number as determined by the Honorable Dog Robber, being issued in sequence and in addition shall bear such name as the members of the Pound may choose, except that no Pound shall bear the name of a living person or of a Pound already in use. ~~It is preferable, but not mandatory, that the Pound bear the name of the Detachment of the MCL from which it obtains the majority of its members.~~

Rationale:

Pounds should not take on the names of Detachments to prevent confusion with State and IRS entities.

CONSTITUTION ARTICLE I – MEMBERSHIP

Existing Wording:

SECTION 107: Delinquency

- A. Any member of the MODD who does not have their membership dues in the MODD paid for the current membership year, as stipulated in ARTICLE V – FISCAL AND FINANCE, Section 503, shall be determined to be delinquent.
- B. Should the delinquency extend beyond the last day of the Supreme Growl of the Kennel, they shall be dropped from the rolls for non-payment of membership dues.

Proposed Wording:

- A. Any member of the MODD who has not paid their membership dues in the MODD for the next membership year by September 1, as stipulated in ARTICLE V – FISCAL AND FINANCE, Section 503, shall be determined to be delinquent.
- B. The delinquent member may remain in delinquent status for a maximum of one year, during which time the member can return to good standing by paying delinquent dues with no reinstatement penalty.
- C. Should the member remain delinquent at the end of one year, he/she shall be removed from the active membership roster. If the member wishes to reactivate his/her membership after being removed from the active roster, he/she must pay a reinstatement fee as stipulated in Section 108: Reinstatement.

Rationale:

The Supreme Growl of the Kennel does not end the Membership Year and we have not dropped members at that point for a number of years. This amendment clarifies the delinquency of past-due members and when members are removed from the active roster.

CONSTITUTION ARTICLE II – POUNDS

Existing Wording:

SECTION 207: Charter – _Surrender / Suspension / Revocation

C 5. Any Pound, the Charter of which has been revoked, shall surrender to the Pack having jurisdictional authority over said Pound, or to the Kennel Executive Director on behalf of the Kennel Board of Trustees as jurisdictional authority, should no Pack having jurisdictional authority exist, all properties and assets to said jurisdictional authority, all properties and assets to said jurisdictional authority, to be held for a period of one (1) year or until a new Pound is formed. Should a new Pound be formed during that period, the new Pound retains the old Pound name and number. ALL properties and assets will be returned. After the one (1) year, the properties and assets shall revert to the jurisdictional authority, Pack or Kennel. The Charter will be returned to the Kennel Executive Director and placed in the archives. All assets will then become the property of the jurisdictional authority, Pack or Kennel.

Proposed Wording:

Strike it from Paragraph C

D. Any Pound, the Charter of which has been **surrendered or** revoked, shall surrender to the Pack having jurisdictional authority over said Pound, or to the Kennel Executive Director on behalf of the Kennel Board of Trustees as jurisdictional authority, should no Pack having jurisdictional authority exist, all properties and assets to said jurisdictional authority, all properties and assets to said jurisdictional authority, to be held for a period of one (1) year or until a new Pound is formed. Should a new Pound be formed during that period, the new Pound retains the old Pound name and number. ALL properties and assets will be returned. After the one (1) year, the properties and assets shall revert to the jurisdictional authority, Pack or Kennel. The Charter will be returned to the Kennel Executive Director and placed in the archives. All assets will then become the property of the jurisdictional authority, Pack or Kennel.

Rationale:

If a Pound decides to surrender their charter and the funds are turned over to the Pack / Kennel to be held in escrow for a year, should the Pound decide to restart, they will have their funds available versus trying to reestablish their funding again.

CONSTITUTION ARTICLE I – MEMBERSHIP

Existing Wording:

SECTION 101: Eligibility

B. Any such other candidate who is in failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, shall, by written request of the Pound with the approval endorsement of the Pack, and with the written permission of the Honorable Chief Devil Dog, be permitted elevation to the next higher degree at a Growl of the Pound, or at a Special Growl of the Pack permit. Pounds that are not part of a functioning Pack may petition the Honorable Chief Devil Dog directly. The written request from the Pound on behalf of a Pup or Devil Dog in failing health shall be accompanied by a statement from competent medical authority specifically addressing the condition of the individual for whom the exemption is being sought. The Pound Keeper's written request shall be countersigned by the Worthy Pack Leader in states where there is a functioning Pack; or, sent directly to the Honorable Chief Devil Dog where there is not a functioning Pack in the state, with a copy of the request sent directly to the Honorable Vice Chief Devil Dog of the respective Division. All requests for medical, World War II, and Korean War service exemptions shall be sent directly to the Honorable Dog Robber for factual verification. Once the Honorable Dog Robber validates, both, the faithful service of the Devil Dog for whom the medical exemption is sought and has determined that the medical evidence provided is compelling and complete; the Honorable Dog Robber shall obtain from the Honorable Chief Devil Dog such approval (either in hard copy or digitally) of the request of either the Pound or the Pack as determined to be sufficient for record-keeping purposes and, by direction, notify the Pound or the Pack as soon as possible that the request for World War II, Korean War Veteran wartime service and/or medical exemption has been granted. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The Honorable Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

Proposed Wording:

B. Any other member who is in **long-term** failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, may request a special advancement at a Growl of the Pound or Special Growl of the Pack. Requests for special advancement must be submitted via the member's Pound, endorsed by the Pack, and approved by the Honorable Chief Devil Dog. Pounds that are not part of a Pack may petition the Honorable Chief Devil Dog directly.

ADD

C. A request for advancement of an eligible member who is a World War I, World War II, or Korean War Veteran as referenced in Section 108 (4) (a) should be submitted to the Honorable Dog Robber with an endorsement letter from the Pound Keeper and a copy of the member's DD-214.

D. A request for special advancement due to medical exemption must be submitted to the Honorable Dog Robber and must include the following:

- i. Request letter from the Pound Keeper, endorsed by the Pack Leader, stating the involvement of the member in the Pound.
- ii. Letter from the member's doctor stating that due to the member's long-term medical condition, travel in any manner is not possible (note: the specific medical condition does NOT have to be shared, only that the member will not be able to travel for the foreseeable future)

E. Once the Honorable Dog Robber receives and validates the information Exemption; he/she shall obtain from the Honorable Chief Devil Dog approval for the Advancement. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The respective Division Vice Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

Rationale:

The current wording the Bylaws is a long run-on sentence that is unclear and hard to read. By breaking up Paragraph B into more management bits and explaining the requirements, we give the Pounds better guidance on how to proceed to advancing those Dogs who may never be able to join us at a Supreme Growl due to age, infirmities, or medical issues.

SECTION 102: Application

Every application for consideration must be in writing and in triplicate on approved membership application forms, which forms must be fully completed in writing or typewritten, over the signature of the applicant and must be accompanied by supplemental papers pertinent to the degree of membership for which application is filed and as set forth in the applicable subsections of section 101 of these bylaws.

SECTION 209: Pound Officers Elected / Appointed:

ELECTED - The elected Officers of the Pound shall be the Pound Keeper (who shall not concurrently hold the office of Pound Dog Robber), Senior Vice Pound Keeper, Junior Vice Pound Keeper, Pound Smart Dog, Pound Dog Trainer, Pound Police Dog, and Pound Mad Dog.

Proposed Wording:

ELECTED - The elected Officers of the Pound shall be the Pound Keeper (who shall not concurrently hold the office of Pound Dog Robber), Senior Vice Pound Keeper, Junior Vice Pound Keeper, Pound Smart Dog, Pound Dog Trainer, Pound Police Dog, and Pound Mad Dog. **No member may hold more than one elected office but may serve in an elected and appointed office concurrently, except as otherwise stated.**

Rationale:

Each member of the Board of Trustees has one vote. Each Pound should want as many voices on the Board making the decisions as possible. While some Pounds have challenges filling positions, there are Pounds with large memberships that simply don't have members filling elected positions, which is not acceptable. There is no elected or appointed position at the Pound level that is a high-demand role, other than Pound Keeper and Dog Robber. Educating Pound members on the responsibilities of the positions may help increase interest in filling those roles.

- A. A Pound shall be in default if:
1. It is indebted to either Kennel or its Pack.
 2. It does not have a valid Installation Report on file with Kennel by ~~1 March~~ **31 December**.
- (no other proposed changes to this Section)

Rationale:

All Pound elections must be held no later than the end of November (within the 3 months following the Supreme Growl). Why does a Pound need six months following the last eligible day of elections to complete and submit the Report of Installation to the Kennel Dog Robber? Section 319 of the Kennel Bylaws gives the Packs until 30 June to submit ROIs before falling into default, which for some Packs may be less than 30 days, depending on when they hold.

This proposed change will still give Pounds more than adequate time to complete and submit the ROI and more of a grace period than we give Packs in submitting the Report of Installation, especially with the implementation of the Kennel Management Application, which gives the Pounds and Packs the ability to submit the ROI immediately upon the completion of installation.

CONSTITUTION ARTICLE XII – GENERAL

Existing Wording:

SECTION 1209: Life Memberships:

E. PLMs shall be made available at a cost of \$150.00 each for those members of the MODD who are up to and including age 60 years, and for \$125.00 for those members who are age 61 years and above. All applicants shall meet the following criteria. NOTE: Because the PLM is classified as dues (Section 104), the current flat rate of \$100.00 will remain in effect until the close of the Supreme Growl of the Kennel in 2005 and the increase shall become effective at that time.

1. The member shall be a Pedigreed Devil Dog, shall be a PLM of the MCL, and shall have no outstanding obligations to either the MODD or the MCL.

2. Life Memberships in the MODD are to be ultimately transmitted to the Honorable Dog Robber. Life membership dues are based on age. Members up to and including 60 years of age, the dues are \$150; Members age 61 and older, the dues are \$125.00. Payment for life membership dues shall be as follows:

a. The Pound Dog Robber shall remit a check deducting \$30.00 (*e.g., members of the MODD up to and including 60 years of age, the Pound Dog Robber shall remit a check in the amount of \$120.00. For members of the MODD 61 years and older, the check amount shall be \$95.00*)

i. If the member belongs to a Pound in a state with NO established Pack, the life membership transmittal, along with the appropriate payment will be forwarded to the Honorable Dog Robber

ii. Checks referred to in section 1209-E-2.a shall be made payable to the MODD Kennel. No further actions will need to be taken if there is NO established Pack in the state where the Pound exists.

iii. Pounds in a state WITH an established Pack shall continue to instructions listed below.

b. If the member belongs to a Pound in a state WITH an established Pack, the life membership transmittal, along with the appropriate payment will be forwarded to the Pack Dog Robber.

i. The Pound Dog Robber shall remit two checks; one check of the required amount made payable to the MODD (state) Pack, and one check of the required amount (*based on the applicant's age*), made payable to the MODD Kennel. The Pack Dog Robber shall retain the Pack's portion, then forward the other check, along with the Life

Membership transmittal to the Honorable Dog Robber. Refer to the MODD Dog Robber's Manual for the current Life Membership amounts for the Pack and the Kennel.
c. In the event of Kennel Strays purchasing life memberships, the Stray shall remit payment directly to the Honorable Dog Robber.

i. If the Stray is up to and including 60 years of age, the amount shall be \$150.00. If the Stray is 61 years and older, the amount shall be \$125.00. Checks shall be made payable to the MODD Kennel.

ii. The Honorable Dog Robber will process the PLM transmittal for the Stray.

3. The transmittal of PLMs shall be the responsibility of the Pound, via the Pack, to the Honorable Dog Robber. Pounds in states having no established Pack shall transmit directly to the Kennel.

4. Permanent metal PLM plates and cardboard type membership cards will be issued to the Pedigreed Devil Dog only at the time of their original transmittal.

5. Pedigreed Devil Dogs holding PLM status in the MODD are exempt from future Kennel, Pack, and Pound membership dues in that Pound.

Proposed Wording:

E. PLMs shall be made available based on age. Members up to including 60 years of age, the dues are \$150; Members aged 61 and older, the dues are \$125.00. All applicants shall meet the following criteria. NOTE: Because the PLM is classified as dues (Section 104), the current flat rate of \$100.00 will remain in effect until the close of the Supreme Growl of the Kennel in 2005 and the increase shall become effective at that time.

1. The member shall be a Pedigreed Devil Dog, shall be a PLM of the MCL, and shall have no outstanding obligations to either the MODD or the MCL.

2. Life Memberships in the MODD are to be ultimately transmitted to the Honorable Dog Robber. ~~Life membership dues are based on age. Members up to including 60 years of age, the dues are \$150; Members age 61 and older, the dues are \$125.00. Payment for life membership dues shall be as follows:~~ *redundant sentence to paragraph E. Strike parts a, b, & c about submission of Life Membership Transmittal.*

3. The transmittal of PLMs shall be the responsibility of the Pound, via the Pack, to the Honorable Dog Robber. Pounds in states having no established Pack shall transmit directly to the Kennel.

4. *A MODD Life Member Number*, Permanent metal PLM plates and cardboard type membership cards will be issued to the Pedigreed Devil Dog only at the time of their original transmittal. *A single Life Member number shall be issued, regardless of the number of Pounds a member may be a Life Member of.*

5. *Life Membership applies only to the Pound to which it is paid. Should a member wish to be a Life Member in more than one Pound, PLM fees must be paid for each Pound.* Pedigreed Devil Dogs holding PLM status in the MODD are exempt from future Kennel, Pack, and Pound membership dues in that Pound.

Rationale:

This edit shortens the section in the Bylaws regarding the payment of the PLM fees, clarifies the payment of the PLM fees to each Pound, makes the main paragraph less verbose, and removes a wording redundancy. The breakdown of how the PLM fees should be submitted is better placed in the Dog Robber Manual / Admin Procedure as the "how" it should be done.

ARTICLE I – MEMBERSHIP

Currently Reads:

Section 101: Eligibility

B. The degrees of membership in the MODD and the time and place the degrees will be conferred are herewith and hereby established as follows:

4. EXCEPTIONS:

a. Any qualified candidate who has otherwise complied with paragraphs D and E of this Section and who is also a World War I Veteran, World War II Veteran, Korean War Veteran (service between 27 June 1950 to 27 July 1954 - dates eligible for the Korean Service Medal: ref DOD), and any service prior to 27 June 1950 would also qualify for advancement to the rank of Pedigreed Devil Dog. The aforementioned candidates would not be required to attend the Supreme Growl of the Kennel to be elevated.

Add the following sub paragraph:

1) For any Devil Dog with (1) year time in Degree that does not meet the above Conflict criteria and is Eighty-Two (82) human years old would also qualify for advancement to the rank of Pedigreed Devil Dog. The aforementioned candidates would not be required to attend the Supreme Growl of the Kennel to be elevated.

Rational: In the near future we are going to have 20-year span of Cold War Veterans that will be advancing in age and will not be eligible to advance to Pedigree under the conflict exceptions.
